Notice Inviting E-tender Hiring of Manpower for Solid Waste and Waste Water Management of WSSP

Water and Sanitation Services Peshawar (WSSP) has been established by the Government of Khyber Pakhtunkhwa and formally registered under Section 42 of the Companies Ordinance 1984 to provide integrated and improved drinking water, Sanitation and Solid waste management services in Peshawar.

WSSP is in the process of improving SWM services in Peshawar. To meet its workforce requirements, WSSP endeavors to hire the services of labour-providing firms / Companies registered with the Government tax authorities and having an Active status on ATL for all applicable taxes. The qualified firm must register itself with KPRA before the award of the contract if not already registered.

The main responsibility includes providing of skilled and unskilled workers to WSSP on a contractual / need basis. Based on the salary reimbursement model. To accomplish this, WSSP intends to invite sealed e-Bids under the Single stage two envelopes method of KPPRA Rules 2014 from well-reputed firms, companies engaged and having required experience in providing workforce & Human resources, divided into the following packages: -

Package	Description
Package-I	Hiring of Manpower for Solid Waste and Waste Water Management within the Jurisdiction of Zone-A
Package-II	Hiring of Manpower for Solid Waste and Waste Water Management within the Jurisdiction of Zone- B&E
Package-III	Hiring of Manpower for Solid Waste and Waste Water Management within the Jurisdiction of Zone-C&D

The interested and eligible bidders/contractors should register themselves on the EPAD link https://kp.eprocure.gov.pk/#/supplier/registration before bid submission on EPAD, under the Single stage two-envelope method of KPPRA Rules. The bid must be submitted/uploaded through EPADS on or before **08th May 2025 at 11:00 am**; the technical bids on EPADS (ebidding) shall be opened on the same day at 11:30 am. The procuring entity shall evaluate the technical proposals in the manner as prescribed in the bid document and shall reject any proposal which doesn't conform to the specified requirements. The financial bids of technically accepted / responsive bids shall be opened publicly at the time, date and venue, which will be communicated to the bidder after technical evaluation through the provided email address.

The Two (2%) CDR of the bid price in the name of "WSSP Contractor Securities" Bok Phase - V, Hayatabad must be submitted through a sealed envelope to the WSSP office, address as mentioned below. The CDR envelope must be clearly and boldly marked as "CDR FOR BID Hiring of Manpower for Solid Waste and Waste Water Management of WSSP (Package #)" before the closing date and time.

A pre-bid meeting will be held on **30th April 2025 at 3:00 pm**.
