Water and Sanitation Services Peshawar (WSSP) was established by the Government of Khyber Pakhtunkhwa and formally registered under Section 42 of the Companies Ordinance 1984 to provide integrated yet improved drinking water, sanitation and solid waste management services in district Peshawar. The sealed e-tenders are hereby invited from income tax registered suppliers/firms/manufacturers for the **Supply of Sanitation tools for WSSP Zone A, B, C, D & E offices** on EPAD and as per the following terms and conditions: -.

General Terms and Conditions

1. The interested and eligible bidders/contractors should register themselves on the EPAD link i-e <https://kp.eprocure.gov.pk/#/supplier/registration>, to submit bids on EPAD under the single-stage single-envelope method of KPPRA Rules.
2. The bids must be submitted/uploaded through EPADS on or before **13th May 2025 at 11:00 am the bids shall be opened on the same day at 11:30 am.**
3. The Two (2%) CDR of the bid price in the name of **“WSSP Contractor Securities”** Bok Phase -V, Hayatabad must be submitted through a sealed envelope to the WSSP office, address as mentioned below. The CDR envelope must be clearly and boldly marked as **“CDR FOR SUPPLY OF SANITATION TOOLS”** before the closing date and time.
4. The Prebid meeting is scheduled on **07th May 2025, 3:00 pm at WSSP Conference Room** as per below mentioned address.
5. The bids must be submitted through EPADS (E-Pak Acquisition and Disposal System) the manually submitted bids shall be rejected.
6. The successful bidder should ensure quality and delivery of required sanitation tools to respective Zonal offices within the jurisdiction of WSSP before the upcoming Eid ul Azha 2025.
7. The bid documents must be **stamped and signed** by an authorized person of the contractor / firm. All federal and provincial duties/stamp duty/taxes will be recoverable as per directives of the government issued from time to time.
8. The bidders are requested to register themselves on the WSSP website via the URL address: <https://wsspeshawar.org.pk/serv/vendor-registration-from>
9. Any disfiguring/overwriting, or manipulation in the tender shall be liable to rejection. Incomplete / conditional bids shall not be acceptable. Other terms and conditions are available with the bidding documents.
