- 1. Interested and eligible bidders/contractors should register themselves on the EPADS link https://kp.eprocure.gov.pk/#/supplier/registration before submitting their bids on EPADS, under the Single Stage Single-Envelope method of KPPRA Rules (Technical / Financial Bids)
- 2. Bids must be submitted/uploaded through EPADS on or before **August 12th, 2025, till 11:00 am**. The bids of participating bidders submitted through EPADS (only) will be accepted and opened publicly on 12th August 2025 at 11:30 am.
- 3. The Two (2%) original CDR of the total bid price in the name of "WSSP Contractor Securities" Bok Phase -V, Hayatabad must be submitted through a sealed envelope to the WSSP office, address as mentioned below. The CDR envelope must be clearly and boldly marked as "CDR FOR A(M&R) Civil works Zone___" before the closing date and time. A separate CDR will be required for each package / Zone.
- 4. The interested bidders should deposit a fee of PKR 3000/- (non-refundable) payable in WSSP A/C Bank of Khyber Phase 3 Chowk Hayatabad Peshawar (IBAN # PK49 KHYB 0083 0020 0915 2876) immediately after the publication of the advertisement in newspapers. The deposit slip fee amounting to Rs. 3000/- must be submitted before the closing date and time along with CDR.

- 6. It is suggested that bidders may participate in up to two Packages / Works. So that the performance of the work remains efficient and prompt based on their operational capabilities and abilities, for smooth operational activities during the period of the contract.
- 7. Subcontracting/subletting of works is not allowed. If the contractor /firm is found to be involved in subcontracting after the award of the Contract (wholly or partially). The awarded contract will be cancelled immediately. The bid security will be forfeited, and the firm / Contractor will be recommended to PEC for black listing/debarment.

All federal and provincial duties/stamp duty/taxes, including KPRA Taxes, will be recoverable as per directives of the government issued from time to time.
