

NOTICE INVITING E-TENDER (EPADS)

The Sealed e-tenders (EPADS) on percentage Above / below on Engineering cost estimate based on MRS-2025 (1st Bi-Annual) are hereby invited from the Income tax, KPRA and PEC Registered contractors / Firms (having valid registration) in Category C-5 and above having Code: CE-09 for the Work; **“Supply and Installation of Manholes Covers within the Jurisdiction of Zone A, B, C, D & E WSSP”** as per following details:-

Terms & Conditions.

1. Interested and eligible bidders/contractors should register themselves on the EPADS link <https://kp.eprocure.gov.pk/#/supplier/registration> before submitting their bids on EPADS till **Tuesday 20th January 2026** or before.
2. Bids must be submitted/uploaded through EPADS on or before **20th January 2026, till 11:00 am**. The bids of participating bidders submitted through EPADS (only) will be accepted and opened publicly on **20th January 2026** at 11:30 am.
3. ORIGINAL two (2%) CDR of the total bid price in the name of **“WSSP Contractor Securities”** and an affidavit regarding original 02% CDR shall be separately sealed and put in separate envelopes and marked as **“CDR and Affidavit FOR Supply & Installation of Manholes Covers Package _____”**. The envelopes containing the ORIGINAL CDR and an affidavit regarding 02% CDR will be put in one large sealed envelope and shall reach on below given address before the closing date and time. A separate CDR will be required for each package / Zone.
4. For the Smooth and prompt completion of work each Package will be awarded to separate bidder.
5. The interested bidders should deposit a fee of PKR 3000/- (non-refundable) payable in WSSP A/C Bank of Khyber Phase-3 Chowk Hayatabad Peshawar (IBAN # PK49 KHYB 0083 0020 0915 2876) immediately after the publication of the advertisement in newspapers. The deposit slip fee amounting to Rs. 3000/- must be submitted before the closing date and time along with CDR.
6. A pre-bid meeting will be held on **13th January 2026 at 3:00 pm** at **WSSP Conference Room** as per address mentioned below.
7. The Manhole covers which includes (Reinforced Plastic Composite RPC /RCC etc.) will be supplied with different load capacity details will be provided in the bidding documents / BOQs.
8. The contractor will ensure supply of high standard / good quality of RPC Manhole covers. The quality and load bearing capacity test will be conducted as mentioned in the Bidding documents.
9. The manhole covers will be installed / fixed ensuring warranty of 06 months with free replacement if broken / damaged during warranty period after installation.
10. The WSSP logo as per WSSP design, Load capacity and Size will be clearly embossed in each RPC Manhole Cover, anti-theft feature will be provided in RPC Manhole covers.
11. Subcontracting/subletting of works is not allowed. If the supplier / firm is found to be involved in subcontracting after the award of the Contract (wholly or partially). The awarded contract will be cancelled immediately. The bid security will be forfeited, and the firm / Contractor will be recommended to PEC for black listing/debarment.

12. The bid must be stamped and signed by an authorised person of the firm. All federal and provincial duties/stamp duty/taxes, including KPRA Taxes, will be recoverable as per directives of the government issued from time to time. The firm must be a registered entity with KPRA. (Rule: 37A of KPPRA).
13. Any disfiguring/overwriting, or manipulation in the uploaded tender/BOQ shall be liable to rejection. Other terms and conditions are available in the BSD.
