3. **The Prebid meeting in WSSP Conference Room on address given below shall be held on Thursday 20<sup>th</sup> April 2023 at 11:00 am.**

Two percent (02%) of the total bid cost must be accompanied with the tender document in the shape of call deposit from scheduled bank of Khyber Pakhtunkhwa in the name of **Chief Executive Officer WSSP Peshawar**. The tender documents must be signed and stamped by the contractor / authorized person of the firm.
5. Only Manufacturer / Authorised dealers and Companies registered with Income tax and sales tax / KPRA department and having valid Licence for vehicle tracking are eligible to participate in the tender (the documentary proof will be required).
6. Sealed proposal shall reach the office of the undersigned up to **3:00 PM on Friday 28<sup>th</sup> April 2023 and will be opened on the same day at 03:30 PM** in the presence of Suppliers or their authorized representatives who wishes to attend.
