- b) The interested bidders /parties wishing to participate in the auction may download auction documents from WSSP website or may obtained these documents from office of WSSP free of cost during working hours.
- c) The bidders will be required to submit a call deposit (from scheduled banks of Pakistan) as token money in the name of Chief Executive WSSP separately for each lot on or before auction date. The CDR amount as token money is mentioned against each lot of **(Table -II)**.
- d) The bidders / parties interested to participate in the auction are required to provide copy of CNIC, contact details and original / copy of CDR for registration in the auction process on or before due date.
- e) The call deposit of unsuccessful bidder shall be refunded.

2. Inspection of Recyclables.

The interested bidders are encouraged to inspect / examined the material / recyclable at WSSP Transfer stations and Land fill site as per location mentioned in **(Table -I)** above on any working day during office hours in coordination of WSSP staff as mentioned in **(Table-I)** (if required). The estimated Solid waste at these locations majorly includes: -

- a. Paper
- b. Plastic
- c. Textiles
- d. Tetra packs
- e. Metal
- f. Glass

3. Bid Evaluation Criteria:

The bids shall be evaluated on the basis of competitive offers i-e (highest ranked bidder).

4. Mode of Payment.

The participated bidders will be required to offer bid per month. The successful bidder will be required to pay 50% of the bid amount at the start of each month before 5th and 50% at the end of the month before 5th of each month.

5. Contract;

The highest ranked bidder will sign a contract with WSSP for the period of one year for collection recyclables from mentioned sites. Which may be extended on satisfactory performance and after increase in rates as per market analysis by WSSP.

6. Security Deposit:

The applying bidders will be required to submit a call deposit from scheduled banks of Pakistan of the amount as mentioned against each lot as token money for the bid in the name of Chief Executive WSSP Peshawar. The security money will be retained till the completion of the contract period from the successful bidder. However, the call deposit of unsuccessful bidder will be returned.

7. Terms and Condition.

- a) The offered bid (base price) will be inclusive of all taxes.
- b) The estimated amount as mention in **Section 1(a) Table-II** and approximate quantities mentioned in **“Table III”** are indicative for auction purposes. The bidder / interested parties shall assess the expected values of recyclables.
- c) WSSP does not assure to provide the quarantines mentioned in **“Table III”** these are indicative estimates. The bidders will be responsible to collect and segregate any quantity of recyclables as per his capabilities on **“AS IT - WHERE IT IS”** basis.
- d) The successful bidder will provide list of staff to be allowed on each TS / LFS. It is the joint responsibility of WSSP and bidder not to allow / expel un-authorized persons collecting recyclables from these sites.
- e) The WSSP staff will NOT be allowed to recover resources from these sites (TS / LFS).
- f) The authorizes staff of the bidder will collect recyclables from these sites on daily basis.

- g) Auction will be conducted for each location separately. However, vendors can participate in more than one lot.
- h) The bid security as mentioned in the above table will be submitted by the bidders for each lot separately.
- i) The auction shall be conducted by WSSP auction committee as per standard procedure in vogue.
- j) The successful bidder shall pay all applicable Govt. taxes / KPRA taxes as per prevailing rates.
- k) The competent authority reserves the right to accept or reject the bid or bids assigning cogent reason thereof.
