The applying / interested bidders will be required to submit a call deposit as bid security in the name of Chief Executive Officer WSSP, Bank of Khyber Phase-III Chowk Hayatabad (IBAN # **PK49 KHYB 0083 0020 0915 2876**) on or before date of auction as mentioned in the above table, along with copy of CNIC, Contact details. The call deposit shall be refunded to unsuccessful bidder after completion of the auction process. The auction will be held on the date / time and address mentioned in the above table. Only call deposit in the name of Chief Executive Officer WSSP will be accepted.
2. Bidders are advised to inspect vehicles scrap at the location / address mentioned above prior of auction date and time and bidders are informed to bring copy of CNIC and CDR at the time of registration to WSSP.
3. The highest ranked bidder will be required to deposit one-fourth (1/4<sup>th</sup>) of the bid amount with WSSP on the same day in shape of Demand draft, CDR or Cash deposit directedly in WSSP Bok Bank Account in the name of Chief Executive Officer WSSP, Bank of Khyber Phase-III Chowk Hayatabad, otherwise his bid shall be considered as cancelled and security amount shall stand forfeited in favor of WSSP.
4. The highest bidder will have to deposit the remaining bid amount within 7-days of approval of bid, otherwise the deposited (1/4<sup>th</sup>) and security amount shall stand forfeited.
5. Base price inclusive of all government applicable taxes to be announced at the time of auction.
6. The successful bidder will be required to collect all the scrap material immediately by deputing their own resources after award of contract and if the site is not cleared by the successful bidder within 10-15 working days, penalty may be imposed.
7. All types of security and safety measures shall be the responsibility of the successful bidders & WSSP will not be responsible for any loss or damage sustained or caused to scrap material after auction.
8. The competent authority reserves the right to accept or reject the bid or bids assigning cogent reason thereof.
