Notice Inviting Tender Hiring of Revenue Officers and Inspectors for Improvement of Revenue Collection in WSSP

Water and Sanitation Services Peshawar (WSSP) has been established by Government of management Khyber Pakhtunkhwa and formally registered under Section 42 of Companies Ordinance 1984 to provide integrated and improved drinking water, Sanitation and Solid waste services for the citizens of Peshawar.

GoKP has notified a new and comprehensive tariff for services of WSSP. In order to improve the revenue collection WSSP has decided to avail the services of 3rd party manpower providers (Contractor). The contractor will deploy team of 05 Nos of Revenue officers and 43 Nos of Revenue Inspectors. These officers and inspectors will work within the jurisdiction of WSSP in Peshawar. They will ensure the revenue collection, improvement in the customer base and all other related functions as described in bidding documents and TORs.

Therefore, WSSP endeavors to hire the services of firms / Companies registered with Govt tax authorities having Active status on ATL for all applicable taxes and registered entity with KPRA. (Under Rule: 37A of KPPRA Rules 2014).

- 2. Those firm fulfilling the eligible criteria of the Bidding documents shall only be considered for the award of contract.
- 3. The bids must include the bid security of not less than 2% of the total bid cost in the shape of CDR in name of Chief Executive Officer WSSP.
- 4. The Bids along with all the relevant documents / BOQ must be delivered to the address mentioned below on or before 12th September 2024 till 03:00 pm preferably through courier services. The bids shall be opened on same day at 03:30 pm at the address mentioned below by the bid preparation and evaluation committee.
- 5. A pre bid meeting will be held on **Wednesday 04th September 2024** at 3:00 pm at WSSP conference room.
- 6. All federal and provincial duties, taxes, stamp duty including sales tax / KPRA taxes will be recoverable as per directives of the government issued from time to time.
- 7. The proposals must be stamped and signed by an authorized person of the contractor / firm. Any disfiguring / over writing, manipulation in the tender / BOQ shall be liable to rejection. Incomplete, conditional, or late submitted bids shall not be acceptable.
