Terms & Conditions

- 1. Interested and eligible Party IIs / suppliers may obtain bidding documents upon written request from the office of undersigned on providing fee slip of PKR: 2000/- (Non-Refundable) payable in the name of Chief Executive Officer WSSP, Bank of Khyber A/C# PK49KHYB0083002009152876, immediately after publishing of advertisement in newspaper up to Thursday 14th November 2024 or may be download from WSSP website / E-Bidding portal (https://wsspeshawar.org.pk/) in the case of download from the website / E-Bidding portal the slip of fee for Rs. 2000/- must be submitted with bid.
- 2. The sealed bids must be submitted till 11:00 am on **Thursday 14^h November 2024** preferably through courier services and will be opened by the Bid preparation and evaluation committee on the same day at 11:30 am in the presence of all the bidders or their authorized representatives, who wishes to attend.
- 3. The Prebid meeting is scheduled to be held on Thursday 07th November 2024 at 3:00 pm Venue: WSSP conference room as per below mentioned address, where the interested bidders will be appraised about bid submission on e-bidding System of WSSP and bidder should also apply through e-bidding along with manual submission of bidding documents in near future only submission through e-bidding system will be allowed.
- 4. 2% Bid Security of the total cost in the shape of call deposit in favor of Chief Executive Officer; WSSP must be accompanied with the bid.
- 5. Quoted rate must be inclusive of delivery at site, all Govt. taxes and duties. All federal and provincial duties/stamp duty / taxes will be recoverable as per directives of the government issued from time to time.
- 6. The bid must be stamped and signed by an authorized person of the Party II.
- 7. The Competent Authority reserves the right to reject any one or all the bids; the reason for rejection shall be communicated to the Contractor / Party II/bidder/supplier upon request.
- 8. The bidders are required to register them self on WSSP website vide URL address: https://wsspeshawar.org.pk/serv/vendor-registration-from.

TERMS AND CONDITIONS

- 1. The tires provided shall be of recognized and reputed brands as per requirements of WSSP Fleet staff.
- 2. The rate(s) quoted shall imply free delivery of the Tires at Wazir Bagh WSSP Workshop including transportation, loading/unloading for inspection by WSSP fleet / zonal staff.
- 3. The rate will be valid and operative for six months from the date of bid submission, validity 6 Months.
- 4. The Successful bidder will supply tires within 20 days or before after award of Purchase Order.
- 5. The payment will be released within 30 to 45 days after delivery of consignment, bill and after verification by zonal office/ Manager Fleet.
- 6. The bidder is required to provide a warranty period of at least 6 months or as per manufacturer.
- 7. The rates should be quoted inclusive of all taxes, delivery at site.
- 8. No extra charge for packing, forwarding and insurance etc. will be paid on the rates quoted.
- 9. The rates should be quoted only for the tires specified in the list of requirements and should be for the items or given specifications of Party II to the standard (s) requirements of the given specification/mark/manufactures.
- 10. Rates quoted for tires other than the required specification/mark/manufacture may not be considered. Similarly supply of Substandard brand or refurbished shall also be rejected at the cost of supplier.
- 11. Where specifications/mark/manufacture is not specified by this office the rates should be quoted only for the 1st Class, standard quality and brand-new tires.
- 12. The decision of the zonal procurement committee for acceptance / rejection of supplied tires / material including the decision for equivalent specifications, standard and quality etc. of tires shall be final.
- 13. The 2% bid security of total bid amount in shape of call deposit will be deposited in the name of Chief Executive Officer WSSP by the bidder.
- 14. The amount of bid security paid by the bidder (s) whose tender are not accepted will be refunded to them by Cross-cheque through finance section of WSSP.

- 15. Only on satisfactory completion of the supply as ordered. The supplier will be liable to submit claim for payment and release of security deposit. The security will be refunded after expiry of guarantee period if any, or any such date/period as may be mutually agreed upon.
- 16. The supply of inferior quality/standard or of different specifications other than that ordered/specified on/or incomplete or damaged articles will not be accepted. The supplier will have to replace the same at his own cost and risk on intimation of non acceptance. However, if no response is received within 10 days from the date of such communication, The WSSP will not be responsible for any damage, loss etc. of such rejected goods.
- 17. In case of failure to replace the unaccepted and rejected goods from supplies made as mentioned in the conditions, the loss undergone by the Government will be recovered from the supplier's security deposit/earnest money or payment due of any bill (s) to the extent required, and the bid security shall be forfeited in favor of WSSP.
- 18. In case of failure to supply the items ordered for as per conditions and within the stipulated time, the same articles will be obtained (if required) from the bidder who has offered next higher rates or from any other source, as may be decided by the procurement committee and loss to the Government on account of such purchase (S) shall be recovered from the former supplier Security Deposit / Ernest Money or bills payable. The suppliers shall have no any right to dispute with such procedure.
- 19. In case of failure is supply the bid security of the bidder may be forfeited and penalty @0.5% per day or maximum up to 10% of the bid value may be imposed under the approval of the competent authority.
- 20. The tenders will be submitted and shall be opened as per time mentioned in NIT in presence of bidders or their representative by WSSP purchase committee at WSSP Head Office Phase 7, Local Council Board Building, Hayatabad Peshawar.
- 21. The right to accept or reject with assigning reasons or all tenders in part or whole is reserved with the purchase committee of WSSP and his decision(s) on all matters relating to acceptance or rejection of the tenders as a whole or in part will be final and binding to all.
- 22. In case supplier does not execute the supply within due date mentioned in the supply order placed with him, the earnest money of the supplier will be forfeited to the Govt. and the contract for the supply shall stand terminated with no further liabilities on either party to the contract.
- 23. The contract agreement shall be executed.
- 24. The tendering Party II must be registered with the Income Tax/FBR and a copy of their registration bearing the registration Number be provided.
- 25. No advance payment will be made and no request for an increase in the rates will be entertained during the period of supply and till payment.

- 26. Bidders should not be permitted to alter or modify their bids after expiry of the deadline for receipt of bids.
- 27. The Purchase Committee reserves the rights to reject any tenders or negotiate as per rules.
- 28. The Purchase Committee also reserves the right to relax any terms and conditions in the public interest.
- 29. The bidder shall indicate their rates in clearly visible figures and words and shall not alter/overwrite/make cutting in the rates. If alteration/overwriting/cutting in rates are noticed, such tenders shall not be taken into consideration until properly verified. The rates quoted should be inclusive of all taxes. Nothing shall be payable over and above the quoted rates and no future liability shall be on the purchaser's side.

3. The Party IIs will provide the tires as per approved specification and brand new, no used or refurbished tires will be accepted by WSSP.

- 4. The approved rate under this Contract shall remain the same during the currency of this Contract for a period of (6 Months). The Party II shall not demand for increase in the approved rate during the period of this Contract.
- 5. Party II will be liable to complete the supply within 20 days after the issuance of the work order. In case of delay due to any reason the Party II may apply for time extension for consideration of the WSSP management.

- 6. The Party I will deduct income tax and sales tax / KPRA taxes or any other admissible tax, if applicable, as per prescribed rates of the Government, which is applicable time to time.
- 7. The Contract may be revoked by the Party I at any time in case of unsatisfactory provision of tires supply or failure to perform services without serving any notice and all payments will be withheld by the Party I and moreover, the legal action will be initiated against the Party II.
- 8. The Party I reserve the right to revoke the contract at any time without assigning any reason thereof and there shall be no appeal before any court or authority against it.
- 9. That the validity of this Contract shall be for 06 months, commencing from the date of work order or as per direction of the Party I.
- 10. If needed, based on requirement, the Party I can proceed with placement of further (Revised) work/supply order within contract period, the Party II will be liable to provide the items on the same rate as per bid document and already approved rates.
- 11. The Party II shall provide the tire product according to the needs and requirements of the Party I and in case of supply of poor-quality, substandard, refurbished supply etc. The Party I has the right to cancel the contract and impose a penalty on the bidder and ban for participating in next bidding process of WSSP.
- 12. Party-I reserve the right to impose penalty of the bidder as per terms and conditions mentioned in the Bidding documents in case failure or unsatisfactory supply.
- 13. Security deposited by the Party II can only be refunded after satisfactory delivery and expiry of warranty (if any).
- 14. Any deviation from the above-mentioned terms of agreement will directly lead to cancellation of the contract and penalty imposition.
